- Innovative Approaches: Exploring innovative methodologies, tools, and technologies for gender-responsive budgeting
- Budgeting for the Well-being Economy and its Benefits for Gender Equality
- Evaluation and Impact Assessment: Assessing the impact of gender-responsive budgeting initiatives, gender audits initiatives and evaluating their effectiveness
- Challenges and Solutions: Identifying challenges faced in the implementation of gender-responsive budgeting and proposing solutions.

Application for a paper by 02 May 2024:

Please submit an abstract of a paper which is on some of the afore mentioned themes and will be no longer than 350 words, including:

- Title
- 3-8 keywords indicating paper's subject, theme and scope
- Paper's presenter's email address and co-author's email address

What happens next?

- After the deadline, Section Chairs approve/decline/reserve all Panels and Papers proposed.
- Approved Papers not submitted as part of a Panel will be allocated to an appropriate Panel.
- Section Chairs may form additional Panels from individual Papers on a similar subject.
- All proposers are informed of the outcome by May 10th, 2024.

Full papers should be between 5,000 to 8,000 words and submitted after the conference by 30.06.2024.

The GBWN will put an effort to prepare a proposal for the book with international publisher, and your chapters might be included in the future monograph ***Gender Responsive budgeting in EU and SEE: Strategies, Initiatives and Practice.***
